

Each such person shall serve as an Authorized Officer of the City until such time as her or his successor shall have been appointed and a written certificate designating her or his successor shall have been delivered to the Fiscal Agent and the Funding Lender.
2. The undersigned, by her/his signature hereon, certifies that the signature appearing opposite each name below is the genuine signature of such person.
3. On behalf of the City, the Mayor has executed by manual signature the Note and delivered the same to the Fiscal Agent for authentication.
